














## COMPARISON OF EXTREME RISK LAWS

Thirteen states have an extreme risk law. However, these laws vary. The chart below gives a brief overview of the different states' laws, including the eligible petitioners, the orders available, the length of the orders, and the legal standard petitioners must meet to prove that the subject of the order is at an elevated risk of harming themselves or others. While each state may use different names for the orders, for simplicity we classify all "emergency", "ex parte", or "temporary" orders issued without notice and hearing as "Ex Parte" orders, and all orders issued after notice and hearing as "Final" orders.
